I retired from Arch Coal Company after twenty-seven years of service. I was promised under the contract I retired from health benefits for life. This gave me and all who retired a sense of security. Now after many years of hard work it looks as if we will have nothing when we need it the most.

Eight years ago I had a massive heart attack. After 9 hours of open heart surgery, and five by passes I struggled to survive. Now I am diabetic and also had to have a defibrillator and pacemaker placed. My cardiologist and endocrinologist has placed me on multiple daily medications to just survive.

If I lose my health care benefits I'll be financially ruined. I would not be able to pay for all of my health care needs.

This would be affecting over 20,000 retirees and their dependents. The retirees, widows, as well as those still working was promised and depended on their retirement and benefits for life.

I feel that this case should take place in West Virginia where we all live and work.

I am respectfully asking you to consider the magnitude that your decision will affect the lives of so many people and their families.

I implore you as a disabled retired miner to make the right decision. May God bless you.
