- 1. On July 9, 2012 (the "<u>Petition Date</u>"), Patriot Coal Corporation and substantially all of its affiliated subsidiary companies ("<u>Debtors</u>") filed voluntary petitions for Chapter 11 Relief. [*See* ECF No. 1]. Debtors' cases are being jointly administered by order of this Court. [ECF No 30].
- 2. Prior to the Petition Date, Jackson Kelly PLLC ("Jackson Kelly") rendered substantial legal services to Debtors in a wide range of areas. Debtors have retained Jackson Kelly with this Courts authorization by its September 10, 2012, *Order Authorizing the Employment and Retention of Jackson Kelly PLLC as Special Counsel for the Debtors Nunc Pro Tunc to the Petition Date* [ECF No. 540] (the "Jackson Kelly Employment Order") nunc pro tunc from the Petition Date to continue to render professional services in connection with (collectively the "Authorized Representation"):
