RECLAMATION REPORT AND NOTICE OF OBJECTION PROCEDURES

PLEASE TAKE NOTICE that:

1. On August 2, 2012, the Court entered an Order Approving Procedures for the Assertion, Resolution and Treatment of Reclamation Claims and Claims Asserted Pursuant to 11 U.S.C. § 503(b)(9) [ECF No. 261] (the "Reclamation Procedures Order").² The Reclamation Procedures Order set forth procedures for the assertion of reclamation claims (each such asserted claim, a "Reclamation Demand") against Patriot

Coal Corporation and its subsidiaries that are debtors and debtors in possession in these cases (collectively, the "**Debtors**").

- 2. Pursuant to the Reclamation Procedures Order, the Debtors were required to compile, review and evaluate the Reclamation Demands to determine: (i) the legal sufficiency of each Reclamation Demand, (ii) whether the relevant goods were in the Debtors' possession when they received the Reclamation Demand, (iii) the invoice amount of the relevant goods and (iv) any setoffs, deductions, credits or other defenses or claims that the Debtors may have against the party asserting each Reclamation Demand. The Debtors have completed this process.
- 3. Pursuant to the Reclamation Procedures Order, the Debtors are required to file on or before November 30, 2012 a report (the "Reclamation Report") including the following information: (i) the names of those vendors asserting Reclamation Demands (the "Vendors"), (ii) the date of each such Reclamation Demand, (iii) the basis on which the Debtors believe that each such Reclamation Demand is not legally valid, if applicable, (iv) a description of the Debtors' proposed treatment of each such Reclamation Demand and (v) any defenses that the Debtors choose to reserve, notwithstanding any allowance of any such Reclamation Demands. The Debtors hereby file the Reclamation Report, which is attached hereto as Exhibit A.
- 4. The Reclamation Report includes information on the legal bases for the Debtors' reduction or disallowance of certain of the Reclamation Demands. The legal bases include the following:
 - (a) Certain amounts have been deemed invalid because the Debtors already paid the amounts included in the Reclamation Demand.
 Other Reclamation Demands were withdrawn by the applicable

- Vendors prior the filing of this Notice. These amounts are listed in the column labeled "Paid/Satisfied/Withdrawn".
- (b) To the extent that a Reclamation Demand was for services and not goods, as required by the Bankruptcy Code and applicable state law, the Reclamation Demand was deemed invalid. The Reclamation Demand amounts that were for services and not goods are listed in the column labeled "Non-Goods".
- (c) Certain Reclamation Demands were deemed invalid to the extent the relevant goods were not received within the proper time periods. These amounts are listed in the column labeled "Received Outside of Period".
- (d) Certain amounts were deemed invalid because the goods relating to those amounts were not identifiable or were not in the Debtors' possession at the time of the Reclamation Demand. These amounts are listed in the column labeled "Goods Consumed or Not Identifiable". Among the reasons that the goods might be "Goods Consumed or Not Identifiable" are that: (i) the goods were consumed, transformed or disposed of prior to receipt of the relevant Reclamation Demand, (ii) the goods were delivered to a third party and were not in the Debtors' possession at the time of the receipt of the relevant Reclamation Demand and (iii) the goods were commingled with like goods from other vendors and therefore were not identifiable.
- (e) Certain Reclamation Demands were deemed invalid because they were received after the deadline set forth in the Reclamation Procedures Order. The amounts described in this paragraph are listed in the column labeled "Late Filed".
- (f) Certain Reclamation Demands asserted claims in amounts that differed from the amount that the Debtors have recorded on their books as owed to the Vendor. In these instances, the Debtors dispute the amount of the Reclamation Demand to the extent that it differs from the amount recorded on the Debtor's books. The amounts described in this paragraph are listed in the column labeled "Does Not Match Books and Records".
- (g) To the extent that a Reclamation Demand included only a general demand and the Vendor did not provide additional information in time³ for the Debtors to analyze the Reclamation Demand, the

³ Pursuant to the Relcamations Procedures Order, the Debtors have requested additional documentation from certain Vendors that submitted Reclamation Demands that provided insufficient information, and the deadline for submitting such documentation has not yet passed.

- Reclamation Demand was deemed invalid. The amounts for which the Reclamation Demand included insufficient information are listed in the column labeled "Insufficient Documentation".
- (h) Certain amounts were deemed invalid because the Debtors believe that the relevant goods are subject to a prior security interest. See In re Dana Corp., 367 B.R. at 409, (holding that reclamation claims were valueless where the reclaimed goods were subject to an existing creditor's prior lien); see also In re Dairy Mart Convenience Stores, Inc., 302 B.R. 128, 134-36 (Bankr. S.D.N.Y. 2003) (holding that reclamation claims were without value in light of a secured lender's prior floating lien on the debtor's inventory); 11 U.S.C. §546(c) (expressly subjecting a seller's right to reclaim goods to the "prior rights of a holder of a security interest in such goods or the proceeds thereof..."). The Debtors are party to a certain prepetition credit agreement that was secured, inter alia, by all goods in the Debtors' possession. The amounts that the Debtors deem invalid because the relevant goods are subject to such prior security interests are listed in the column labeled "Subject to Prior Security Interest".
- 5. Pursuant to the Reclamation Procedures Order, the Debtors will serve this Notice and the Reclamation Report by facsimile, overnight or hand delivery, on: (i) the Office of the United States Trustee for the Southern District of New York, 33 Whitehall Street, 21st Floor, New York, New York 10004, Attn: Andrea B. Schonholtz and Ana Alfonso and (iii) counsel to the Official Committee of Unsecured Creditors, Kramer, Levin, Naftalis & Frankel LLP, 1177 Avenue of the Americas, New York, New York 10036, Attn: Adam C. Rogoff, Esq. and Gregory G. Plotko, Esq. This Notice and the Reclamation Report shall also be served, by U.S. mail, on each of the Vendors with a claim identified in the Reclamation Report.

- 6. Pursuant to the Reclamation Procedures Order, any objections to the Reclamation Report (each, an "Objection") must be filed with the Court and served upon (i) the Debtors, either by facsimile transmission to (314) 275-3626 or delivery to Patriot Coal Corporation, 12312 Olive Boulevard, Suite 400, St. Louis, Missouri, 63141, Attn: Marguerite A.  need for further order of the Court. Such treatment shall include the allowance, without
 the need for further order of the Court, of an administrative claim to be paid pursuant to

any plan of reorganization to the extent and in the amount listed in the column in the Reclamation Report labeled "Proposed Administrative Claim Amount."

- 8. Pursuant to the Reclamation Procedures Order, for each Reclamation Demand in the Reclamation Report as to which an Objection is timely received but subsequently settled by agreement among the Debtors and the relevant Vendor, such Vendor shall receive (unless otherwise agreed by the Debtors), without the need for further order of the Court, an administrative claim to be paid pursuant to any plan of reorganization in the amount agreed by the Debtors and the relevant Vendor; *provided* that any such settlement shall be subject to the provisions of any order of the Court establishing procedures for the settlement of claims.
- 9. Pursuant to the Reclamation Procedures Order, for each Reclamation

 Demand in the Reclamation Report as to which an Objection is timely received and not subsequently settled by the parties, such Reclamation Demand shall not be deemed valid or invalid except upon further order of the Court after, the Debtors request a hearing on such Reclamation Demand.
