I WAS EMPLOYED BY ARCH OF ILLINOIS AT PIPESTONE CREEK STRIP MINE AS - OR MY CLASSIFICATION WAS "SHOOTER" OR BLASTER ON THE OVERBURDEN DRILL'S WHICH DRILLED HOLES TO A DEPTH OF ABOUT AVERAGE 50 FT DEEP MY JOB WAS TO LOAD THE HOLES WITH "EXPLOSIVES" AND TO SHOOT OR BLOW UP THE OVERBURDEN ON TOP OR COVERING THE COAL SEAM WHICH WAS ABOUT 6 FEET THICK.

ON OR ABOUT FIRST OF SEPTEMBER 1987 AT ABOUT 10:00 PM I WAS INJURED IN AN ACCIDENT WHILE WORKING AT MY JOB AS A "SHOOTER" AS A RESULT OF THIS ACCIDENT I WAS PERMANENTLY DISABLED AND HAVE NOT WORKED A DAY SINCE ACCIDENT 25 YEARS AGO,

MY ONLY INCOME IS SOCIAL SECURITY  
 DISABILITY AND \$316.62 FROM THE UNITED  
 MINE WORKERS OF AMERICA THIS AMOUNT  
 HAS STAYEN THE SAME FOR 25 YEARS. I  
 FEEL THE UNITED MINE WORKERS HAVE LET  
 ME DOWN FROM THE START OF MY ACCIDENT  
 25 YEARS AGO. I LET THE UNITED MINE  
 WORKERS FOR THE FRIST FEW YEARS OF MY  
 DISABILITY DEDUCT \$6.00 PER MONTH OUT  
 OF MY DISABILITY PENSION OF ONLY \$316.62 A  
 MONTH. I WROTE A LETTER TO U.M.W.A.

PENSION FUNG IN WASHINGTON, DC. AND SAID  
 PLEASE STOP TAKING THE \$6.00 PER MONTH  
 OUT OF MY CHECK AS I CAN NOT AFFORD  
 THE \$6.00 PER MONTH AS I HAVE LOST  
 EVERY THING I HAVE EVER WORKED FOR IN MY  
 LIFE AND I AM DISABILED AM NO LONGER  
 ABLE TO WORK FOR A LIVING U.M.W.A WAS  
 OF NO HELP TO ME AND I WROTE A  
 LETTER LIKE THIS ONE AND TOLD THEM  
 SO MANY YEARS AGO. MY LIFE IN SHORT  
 HAS BEEN A LIVING HELL! SEVERAL TIMES

AFTER MY ACCIDENT I EVEN CONSIDERED  
 TAKING ON ENDS MY LIFE. I HAVE AND  
 LOST EVERYTHING I HAVE NOTHING! IT WAS  
 MY UNDERSTANDING ARCH WOULD PAY MY  
 MEDICAL BILLS & PHARMACY BILLS & MEDICARE  
 BUT THAT DOES NOT COVER EVERYTHING  
 LIFE IS VERY HARD I LIVE ALONE FOR MANY  
 YEARS AS I CAN NOT AFFORD A COMPANION  
 OR WIFE

I AM ALL ALONE AND JUST TURNED 63 YRS  
 OLD IN NOVEMBER 10. ABOUT 10 YEARS A  
 TORNADO DESTROYED MY MOBIL HOME AND  
 ALL MY BELONGINGS I HAD NO INSURANCE  
 AND SOME FEMA PEOPLE CAME AROUND  
 AND SAID I COULD GET A S.B.A DISASTER  
 LOAN TO REPLACE MY MOBIL HOME. I HAVE  
 DIABETIS NOW FOR ABOUT 10 YEARS AND IT IS  
 GRADUALLY GETTING WORSE AS I AM GOING  
 TO HAVE TO MOVE INTO A NURSING HOME  
 FOR CARE. THIS IS WHY I A CLAIM WITH  
 PATRIOT COAL CORPORATION ET AL - CASE NO.  
 12-51502 (KSS) (THE DEBTORS) GCF, INC IS  
 THE CLAIMS AND NOTICING AGENT IN THE DEBTORS
