503(b)(9) REPORT AND NOTICE OF OBJECTION PROCEDURES

PLEASE TAKE NOTICE that:

1. On July 9, 2012 (the “**Petition Date**”), Patriot Coal Corporation and each of its subsidiaries that are debtors and debtors in possession in these proceedings (collectively, the “**Debtors**”) commenced with the United States Bankruptcy Court for the Southern District of New York (the “**SDNY Bankruptcy Court**”) a voluntary case under chapter 11 of the Bankruptcy Code. On December 19, 2012, the SDNY Bankruptcy Court entered an order transferring the Debtors’ chapter 11 cases to this Court (the “**Transfer Order**”) [ECF No. 1789].² The Debtors are authorized to operate their businesses and manage their properties as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code. These chapter 11 cases are being jointly

administered pursuant to Bankruptcy Rule 1015(b) and the SDNY Bankruptcy Court's Joint Administration Order entered on July 10, 2012 [ECF No. 30].

2. Additional information about the Debtors' businesses and the events leading up to the Petition Date can be found in the Declaration of Mark N. Schroeder pursuant to Local Bankruptcy Rule 1007-2 of the SDNY Bankruptcy Court, filed on July 9, 2012 [ECF No. 4], which is incorporated herein by reference.

3. On August 2, 2012, the SDNY Bankruptcy Court entered the Order Approving Procedures for the Assertion, Resolution and Treatment of Reclamation Claims and Claims Asserted Pursuant to 11 U.S.C. § 503(b)(9) [ECF No. 261] (the "**503(b)(9) Procedures Order**").³ The 503(b)(9) Procedures Order sets forth procedures for the assertion of claims pursuant to section 503(b)(9) of the Bankruptcy Code (each such properly asserted claim, a "**503(b)(9) Demand**") against the Debtors.

4. Pursuant to the 503(b)(9) Procedures Order, the Debtors were required to compile, review and evaluate the 503(b)(9) Demands to determine: (i) the legal sufficiency of each 503(b)(9) Demand, (ii) whether the relevant goods were in the Debtors' possession when they received the 503(b)(9) Demand, (iii) the invoice amount of the relevant goods and (iv) any setoffs, deductions, credits or other defenses or claims that the Debtors may have against the party asserting each 503(b)(9) Demand. The Debtors have completed this process.

5. Pursuant to the 503(b)(9) Procedures Order, the Debtors are required to file on or before February 27, 2013 a report (the "**503(b)(9) Report**") including the

following information: (i) the names of those vendors asserting 503(b)(9) Demands (the “**Vendors**”) that have not successfully been reconciled, (ii) the date of each such 503(b)(9) Demand, (iii) the basis on which the Debtors believe that each such 503(b)(9) Demand is not legally valid, if applicable, (iv) a description of the Debtors’ proposed treatment of each such 503(b)(9) Demand, if any, and (v) any defenses that the Debtors choose to reserve, notwithstanding any allowance of any such 503(b)(9) Demands. The Debtors hereby file the 503(b)(9) Report, which is attached hereto as Exhibit A.

6. The 503(b)(9) Report includes information on the legal bases for the Debtors’ reduction or disallowance of certain of the 503(b)(9) Demands. The legal bases include, but are not limited to, the following:

- (a) Certain amounts have been deemed invalid because the Debtors or a third party already paid or otherwise satisfied the amounts included in the 503(b)(9) Demand. These amounts are listed in the column labeled “Paid/Satisfied”.
- (b) To the extent that a 503(b)(9) Demand was for services and not goods as required by the Bankruptcy Code, the 503(b)(9) Demand was deemed invalid. The 503(b)(9) Demand amounts that the Debtors believe were for services and not goods are listed in the column labeled “Services, Not Goods”.
- (c) Certain 503(b)(9) Demands were deemed invalid to the extent the relevant goods were not received within the proper time period as required by the Bankruptcy Code. These amounts are listed in the column labeled “Goods Received Outside of 20-Day Window”.
- (d) Certain 503(b)(9) Demands were deemed invalid because the Debtors believe they are claims that should be asserted against a non-debtor entity or that the Debtors are otherwise not liable for such 503(b)(9) Demands. In addition, for certain 503(b)(9) Demands, the Debtors (i) did not receive an invoice; (ii) received invoice(s) that differ from the actual goods received or (iii) received duplicative invoices. These amounts are listed in the column labeled “Non-Debtor / Disputed Claim”.

7. Pursuant to the 503(b)(9) Procedures Order, the Debtors will serve this Notice and the 503(b)(9) Report by facsimile, overnight or hand delivery, on: (i) the Office of the United States Trustee for the Eastern District of Missouri, 111 South 10th Street, Suite 6.353, St. Louis, Missouri 63102, Attn: Leonora S. Schonholtz and Ana Alfonso, and (iii) counsel to the official committee of unsecured creditors (the "**Committee**"), Kramer Levin Naftalis & Frankel LLP, 1177 Avenue of the Americas, New York, New York 10036, Attn: Adam C. Rogoff and Gregory G. Plotko. This Notice and the 503(b)(9) Report shall also be served, by U.S. mail, on each of the Vendors with a claim identified in the 503(b)(9) Report.

8. Pursuant to the 503(b)(9) Procedures Order, any objections to the 503(b)(9) Report (each, an "**Objection**") must be filed with the Court and served so as to actually be received on or before **March 19, 2013 at 4:00 p.m. (prevailing Central Time)** by (i) the Debtors, either by facsimile transmission to (314) 275-3626 or delivery to Patriot Coal Corporation, 12312 Olive Boulevard, Suite 400, St. Louis, Missouri 63141, Attn: Marguerite A. 9. Pursuant to the 503(b)(9) Procedures Order, for each 503(b)(9) Demand in the 503(b)(9) Report as to which no Objection is timely received, the 503(b)(9) Demand shall be treated by the Applicable Debtor (as defined below) as set forth in the 503(b)(9) Report without the need for further order of the Court. Such treatment shall include the allowance, without the need for further order of the Court, of an administrative claim subject to and to be paid in accordance with any plan(s) of reorganization or further order of the Court in the amount set forth in the column in the 503(b)(9) Report labeled "Proposed 503(b)(9) Amount" to be paid by the specific corresponding Debtor entity listed in the column in the 503(b)(9) Report labeled "Proposed Debtor" (the "**Applicable Debtor**").⁴

Pursuant to the 503(b)(9) Procedures Order, for each 503(b)(9) Demand in the 503(b)(9) Report as to which an Objection is timely received but subsequently settled by agreement of the Debtors and the relevant Vendor, such Vendor shall receive (unless otherwise agreed by the parties), without the need for further order of the Court, an administrative claim subject to and to be paid by the Applicable Debtor in accordance with any plan(s) of reorganization or further order of the Court in the amount agreed to by the Debtors and the relevant Vendor; *provided* that any such settlement shall be subject to the provisions of the Order Authorizing and Approving Procedures for Compromise and Settlement of Certain Claims, Litigations and Causes of Action [ECF No. 2821] entered by the Court on February 13, 2013.

11. Pursuant to the 503(b)(9) Procedures Order, for each 503(b)(9) Demand in the 503(b)(9) Report as to which an Objection is timely received and not subsequently settled by the parties, such 503(b)(9) Demand shall not be deemed valid or invalid except upon further order of the Court after the Debtors request a hearing on such 503(b)(9) Demand.

12. For the avoidance of doubt, only the Applicable Debtor, and no other Debtor, may be obligated for each respective Proposed 503(b)(9) Amount.
