NOTICE IS HEREBY GIVEN that before the date of filing of the Petitions in these jointly-administered cases, Strata Mine Services, LLC, a subsidiary of Strata Worldwide, LLC (“Claimant”), furnished work and materials to Patriot Coal Corporation, Eastern Associated Coal, LLC, Black Stallion Coal Company, LLC, and/or other affiliates or subsidiaries of Patriot Coal Corporation (the “Debtors”) for use in, *inter alia*, the erection, construction and/or improvement of real property and related facilities known as “Black Stallion Coal Company, LLC, Route 85, P.O. Box 88, Wharton, West Virginia, 25208; Mine No. 1 at or near Jarrell Branch, approximately one-half mile north of Wharton, Crook Magisterial District, Boone County, West Virginia, 25208, Permit Number U-5013-04” and more particularly described in Exhibit 1, attached hereto (the “Property”), for which Claimant has not been paid totaling \$173,431.87, exclusive of finance and other charges (the “Debt”).

NOTICE IS FURTHER GIVEN that, to secure payment of the Debt, Claimant asserts mechanics’ and materialmens’ liens (the “Liens”) against the Debtors’ interest in the Property, including lots and tracts of land and upon the buildings, structure, and improvements thereon and

proceeds, products, offspring, rents, and profits of such Property, pursuant to W. Va. Code § 38-2-1, *et seq.* (the “West Virginia Mechanics’ Lien Law”).

NOTICE IS FURTHER GIVEN that Claimant recorded a Notice of Mechanics’ Lien in the county or counties in which the work was performed within one hundred days of the service dates pursuant to the West Virginia Mechanics’ Lien Law.

NOTICE IS FURTHER GIVEN of the perfection of the Liens in the Property, including lots and tracts of land and upon the buildings, structure, and improvements thereon and proceeds, products, offspring, rents, and profits of such Property. A true and correct copy of the Claimant’s recorded Notice(s) of Mechanics Lien and claim are attached hereto as Exhibit “1.”

NOTICE IS FURTHER GIVEN that Claimant has a right to assert the Liens and intends to assert and enforce the Liens. This Notice is being filed and served pursuant to 11 U.S.C. § 546(b)(2) in lieu of commencement of a suit in chancery pursuant to the West Virginia Mechanics’ Lien Law.
