STIPULATION AND ORDER PURSUANT TO SECTIONS 105(a), 363(b) AND 365(a) OF THE BANKRUPTCY CODE AUTHORIZING AND APPROVING THE ASSUMPTION OF CERTAIN LEASES

WHEREAS, on July 9, 2012 (the "**Petition Date**"), each Debtor commenced with this Court a voluntary Chapter 11 case under Title 11 of the United States Code (the "**Bankruptcy Code**") and the Debtors are authorized to operate their businesses and manage their properties as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code;

WHEREAS, prior to the Petition Date, Debtors Patriot Reserve Holdings, LLC, Kanawha Eagle Coal, LLC, Kanawha River Ventures II, LLC, Kanawha River Ventures III, LLC, Remington II LLC, Remington LLC, and Robin Land Company, LLC (each, an "Applicable Debtor") and certain lessors (collectively, the "LRPB Group") entered into that certain Restatement of Leases and Other Documents dated September 28, 1984 among LaFollette, Robson, Prichard & Broun, et al. and Cedar Coal Co. and The Charleston Bank,

N.A., as Trustee (as amended, assigned, and subleased from time to time, and as set forth on Schedule A² attached hereto, collectively the "**LRPB Lease**"):

WHEREAS, on January 15, 2013 the Debtors filed a Motion For Authorization to (i) Assume or (ii) Reject Unexpired Leases Of Nonresidential Real Property [ECF No. 1995] (the "Motion");

WHEREAS, the LRPB Group filed *LRPB's Limited Objection to Debtors'*Motion for Authorization to Assume or Reject Unexpired Leases of Nonresidential Real Property

[ECF No. 2180] (the "**Objection**");

WHEREAS, this Stipulation and Order will resolve the Objection and avoid any need for further litigation among the parties regarding the LRPB Lease;

WHEREAS, the Applicable Debtors seek the entry of this Stipulation and Order pursuant to sections 105(a), 363 and 365(a) of the Bankruptcy Code and Rules 6004 and 6006 of the Federal Rules of Bankruptcy Procedure authorizing the assumption of the LRPB Lease; and

WHEREAS, each Applicable Debtor has determined in the exercise of its business judgment that entering into this Stipulation and Order is in the best interests of such Applicable Debtor, its estates and all creditors and parties in interest.

NOW, THEREFORE, IT IS HEREBY STIPULATED, ORDERED, AND AGREED, by and between the parties through their undersigned counsel, that:

1. The above recitals are incorporated herein as agreed and so-ordered.

² The descriptions of the LRPB Lease included in Schedule A (including its various amendments, assignments and subleases) are provided for convenience only and are not intended to modify, or to represent the Debtors' interpretation of or a Court determination regarding, the terms of the LRPB Lease.

- 2. The LRPB Group agrees to withdraw the Objection, and agrees not to object to the Motion or any order authorizing the relief requested in the Motion, provided that the Applicable Debtors comply with the terms of this Stipulation and Order.
- 3. Subject to the reservations of rights set forth in this Stipulation and Order, each Applicable Debtor is authorized to assume the LRPB Lease and the LRPB Lease is deemed assumed, pursuant to section 365 of the Bankruptcy Code, effective as of the applicable date set forth on the attached Schedule A.
- 4. The assumption of the LRPB Lease is an exercise of each Applicable Debtor's sound business judgment and is in the best interests of each Applicable Debtor and its estates.
- 5. It is hereby agreed between each Applicable Debtor and the LRPB Group that the amount to be paid to cure all prepetition defaults under the LRPB Lease pursuant to 365(b) of the Bankruptcy Code shall be the applicable cure amount set forth on the attached Schedule A (the "Cure Amounts"),³ or such other amount as may be agreed by the parties; *provided*, *however*, that the Applicable Debtor will obtain the consent of the official committee of unsecured creditors and the administrative agents for the Debtors' postpetition lenders (which consent, in each case, shall not be unreasonably withheld) or further order of the Court prior to agreeing to a Cure Amount that differs from the amount set forth in Schedule A.

³ The Cure Amounts include those prepetition defaults that are required to be cured under section 365(b) of the Bankruptcy Code, but, for purposes of this Stipulation and Order, the parties agree that the Cure Amounts do not include, and each Applicable Debtor shall not be deemed to have satisfied, (i) any defaults that are not yet in existence or (ii) any amount or obligation on account of any presently contingent or unliquidated claims arising from or relating to any environmental condition, claim, or obligation (if any), in each case to the extent provided for under the LRPB Lease, and any such claims are expressly preserved by this Stipulation and Order. Nothing herein shall be construed as an admission by any Applicable Debtor or the LRPB Group that any such claims exist, and all parties' rights are reserved with respect to any such potential claims and defenses thereto. Nothing herein shall supersede or modify the requirements under (a) the Order Authorizing and Approving Procedures for Compromise and Settlement of Certain Claims, Litigations and Causes of Action [ECF No. 2821] and (ii) Rule 9019 of the Federal Rules of Bankruptcy Procedure.

- 6. Upon payment of the Cure Amounts, there shall be no defaults under the LRPB Lease that preclude its assumption, and each Applicable Debtor shall be deemed to have satisfied all of its obligations under section 365(b)(1) of the Bankruptcy Code with respect to the LRPB Lease; *provided, however*, that payment of the Cure Amounts shall not (i) preclude the LRPB Group from asserting a default arising after assumption of the LRPB Lease, or (ii) bar a party to the LRPB Lease from seeking to exercise any right it may have under the LRPB Lease on account of a default arising after assumption of the LRPB Lease.
- 7. Upon payment of the Cure Amounts, the LRPB Group shall be forever barred and enjoined from asserting against each Applicable Debtor any claims for additional cure costs or adequate assurance in respect of the assumption of the LRPB Lease under 11 U.S.C. § 365 other than the Cure Amounts set forth on Schedule A attached hereto.
- 8. Except as set forth in this Stipulation and Order, upon entry of this Stipulation and Order, all of the LRPB Group's claims relating to the LRPB Lease, whether or not evidenced by one or more proofs of claim filed by the LRPB Group, are hereby disallowed and expunged in their entirety without further need for any action by the Debtors or further Court approval.
- 9. For the avoidance of doubt, the Applicable Debtors do not waive their statutory right to later reject the LRPB Lease. If an Applicable Debtor later rejects the LRPB Lease, the resulting damages shall be determined by applicable provisions of the Bankruptcy Code and any other applicable law.
- 10. The Applicable Debtor's rights to assign the LRPB Lease, pursuant to section 365(f) of the Bankruptcy Code is expressly preserved, and the Applicable Debtor may assign the LRPB Lease in the future notwithstanding any provision the LRPB Lease that prohibits, restricts

or conditions the assignment of the LRPB Lease, provided that the conditions of section 365(f)(2) of the Bankruptcy Code are satisfied.

- 11. Except as set forth in this Stipulation and Order, the assumption of the LRPB Lease does not represent a waiver by any party in interest, including the Debtors and the LRPB Group, of any rights, claims or defenses in connection with or arising from the LRPB Lease.
- 12. Each Debtor's estate shall only be obligated under this Stipulation and Order to the extent that such Debtor entity was a party to the LRPB Lease prior to the Petition Date and nothing in this Stipulation and Order and/or the assumption of the LRPB Lease shall obligate any Debtor entity that was not an existing party to the LRPB Lease.
- 13. Each Applicable Debtor is hereby authorized to execute all documentation reasonably necessary to assume the LRPB Lease.
- 14. This Stipulation and Order shall govern renewals or modifications of the Assumed Leases that are done during the pendency of these Chapter 11 cases, in the ordinary course of each Applicable Debtor's businesses and consistent with their past practices.
- 15. Each Applicable Debtor is hereby authorized to pay its obligations under the LRPB Lease in accordance with the relevant terms of the LRPB Lease, without further order of this Court.
- 16. This Stipulation and Order shall inure to the benefit of and shall be binding on the LRPB Group, each Applicable Debtor, and their respective successors in interest and assigns.
- 17. This Stipulation and Order shall only relate to the matters specifically referenced herein.

- 18. Notwithstanding the possible applicability of any Bankruptcy Rule, the terms and conditions of this Stipulation and Order shall be immediately effective and enforceable upon its entry.
- 19. This Stipulation and Order may be signed in counterparts and by facsimile, with each signed counterpart being deemed a part of the original document.
- 20. This Stipulation and Order may not be modified, altered or amended except by a writing signed by the parties hereto, subject to approval of the Court.
- 21. The Debtors, the Debtors' claims and noticing agent, GCG, Inc., and the Clerk of this Court are authorized to take all such actions as are necessary or appropriate to implement the terms of this Stipulation and Order.
