**DEBTORS' NINETEENTH OMNIBUS OBJECTION TO CLAIMS**  
**(Adkins Flood Litigation Claims)**

Patriot Coal Corporation and its affiliated debtors (the "Debtors"), pursuant to 11 U.S.C. § 502 and Fed. R. Bankr. P. 3007, respectfully file this Nineteenth Omnibus Objection to Claims (the "Objection"). In support of this Objection, the Debtors show the Court as follows:

**Relief Requested**

1. By this Objection, the Debtors object to certain claims listed on Exhibit A attached hereto (the "Claims") because the Claims are not supported by the underlying facts. The Debtors request entry of an order, pursuant to Section 502 of the Bankruptcy Code and Fed. R. Bankr. P. 3007, disallowing the Claims.

2. **Parties receiving this Objection should locate their names on the attached exhibit.** Any response to this Objection should include, among other things, (i) an appropriate caption, including the title and date of this Objection; (ii) the name of the claimant, both the EDMO and GCG claim numbers of the claim that the Debtors are seeking to disallow or modify, and a description of the basis for the amount claimed; (iii) a concise statement setting forth the reasons why the Court should not sustain this Objection, including, but not limited to, the

specific factual and legal bases upon which the claimant relies in opposing this Objection; (iv) copies of any documentation and other evidence which the claimant will rely upon in opposing this Objection at a hearing; and (v) the name, address, telephone number and facsimile number of a person authorized to reconcile, settle or otherwise resolve the claim on the claimant's behalf. A claimant that cannot timely provide such documentation and other evidence should provide a detailed explanation as to why it is not possible to timely provide such documentation and other evidence.

### **Jurisdiction**

3. This Court has jurisdiction over this Objection under 28 U.S.C. § 1334. Venue of this proceeding is proper pursuant to 28 U.S.C. § 1409. This is a core proceeding within the meaning of 28 U.S.C. § 157(b)(2).

4. Venue is proper pursuant to 28 U.S.C. §§ 1408 and 1409.

### **Background**

5. Ninety-nine of the Debtors filed voluntary petitions for relief under Chapter 11 of the Bankruptcy Code on July 9, 2012 in the United States Bankruptcy Court for the Southern District of New York.

6. On December 19, 2012, these Debtors' cases were transferred to the United States Bankruptcy Court for the Eastern District of Missouri [Dkt. No. 1789].

7. The bar date for filing proofs of claim against these Debtors was December 14, 2012 [Dkt. No. 1388].

8. On March 1, 2013, the Court entered its Order Establishing Procedures for Claims Objections [Dkt. No. 3021].

9. Debtors Brody Mining, LLC and Patriot Ventures LLC filed voluntary petitions for relief under Chapter 11 of the Bankruptcy Code on September 23, 2013 in this Court. The bar date for filing proofs of claim against these Debtors is October 24, 2013.

### **Objection and Argument**

10. Each of the Claims listed on Exhibit A arises from certain litigation filed in the Circuit Court of Logan County, West Virginia, styled Clifford Adkins, et al. v. Alex Energy, Inc., et al., Civil Action No. 06-C-161-P (the “Litigation”). Two Debtors, Catenary Coal Company, L.L.C. (“Catenary”) and Hobet Mining, LLC (“Hobet”), are among the 28 defendants in the Litigation.

11. 253 of the Claims listed on Exhibit A were filed by plaintiffs in the Litigation, and two Claims were filed by the plaintiffs’ counsel, who seek to recover attorneys’ fees. The liquidated amounts sought in the Claims total \$63,000,000.

12. The Litigation involves flooding that occurred on or about May 31, 2004 and June 4, 2004. The plaintiffs allege that they were “owners or tenants of real property within the Island Creek sub-watershed of the Upper Guyandotte River Watershed” that was lost or destroyed by the flooding. The plaintiffs allege that each of the defendants owns or controls interests in real property located within the Island Creek sub-watershed of the Upper Guyandotte River Watershed (the “Sub-Watershed”) or owns or controls mining operations, timbering operations, or other mineral, oil, or gas extraction industries located in or impacting the Sub-Watershed. The

plaintiffs' claims in the Litigation sound in nuisance, negligence, trespass, and violation of the plaintiffs' riparian rights.

13. The Sub-Watershed is located in Logan County in southwestern West Virginia. Island Creek flows from southern Logan County north to the town of Logan, where it flows into the Guyandotte River. The Guyandotte River flows generally northwest from Logan to the city of Huntington, where it flows into the Ohio River.

14. Neither Catenary nor Hobet owned or occupied real property, mining operations, timbering operations, or other mineral, oil, or gas extraction operations located within or impacting upon the Sub-Watershed in 2004. See Declaration of Gregory Ross, attached hereto as Exhibit B.

15. The operations of Catenary are in Boone, Raleigh, and Kanawha Counties, West Virginia, approximately 30 miles northeast of the town of Logan. Catenary's operations are in the watersheds of the Big Coal River, the Clear Fork, and Cabin Creek. The Clear Fork flows into the Big Coal River near the town of Whitesville. The Big Coal River meets the Little Coal River near the community of Alum Creek to form the Coal River, which flows into the Kanawha River near St. Albans. Cabin Creek flows into the Kanawha River near the town of Cabin Creek. The Kanawha River flows into the Ohio River near Point Pleasant. Catenary's operations were in the same location in 2004.

16. The operations of Hobet are in Boone and Lincoln Counties, West Virginia, approximately 15 miles north of the town of Logan. Hobet's operations are in the watersheds of the Mud River and the Little Coal River. The Mud River flows into the Guyandotte River near Barboursville, approximately 50 miles downstream of Logan. The Little Coal River meets the

Big Coal River near the community of Alum Creek to form the Coal River, which flows into the Kanawha River near St. Albans. Hobet's operations were in the same location in 2004.

17. From a hydrological perspective, the properties and operations of Catenary and Hobet are either entirely separate from or far downstream from the plaintiffs' properties. Regardless of the legal theory asserted by the plaintiffs, neither Catenary nor Hobet could have been responsible for flooding on the plaintiffs' properties in 2004.

18. The plaintiffs thus are not entitled to any relief on the allegations included in the Claims, nor are their attorneys entitled to fees. The Claims should be disallowed.

WHEREFORE, the Debtors respectfully request that this Court:

- (a) disallow the Claims; and
- (b) grant such other and further relief as is just and proper.

**DECLARATION OF GREGORY A. ROSS IN SUPPORT  
OF DEBTORS' NINETEENTH OMNIBUS OBJECTION TO CLAIMS**

Gregory Ross declares, pursuant to 28 U.S.C. § 1746, to the best of his knowledge and based upon the documents available to him, as follows:

1. I am the Director of Permitting and Planning for Patriot Coal Services, LLC.
2. In connection with my employment, I am familiar with the current and historical locations of the properties and operations of Patriot Coal Corporation and its affiliates, including Catenary Coal Company, L.L.C. (“Catenary”) and Hobet Mining, LLC (“Hobet”), and the associated watersheds in which they operate.
3. Neither Catenary nor Hobet owned or occupied real property, mining operations, timbering operations, or other mineral, oil, or gas extraction operations located within or impacting upon the Island Creek sub-watershed of the Upper Guyandotte River Watershed (the “Sub-Watershed”) in 2004.
4. The Sub-Watershed is located in Logan County in southwestern West Virginia. Island Creek flows from southern Logan County north to the town of Logan, where it flows into

the Guyandotte River. The Guyandotte River flows generally northwest from Logan to the city of Huntington, where it flows into the Ohio River.

5. The operations of Catenary are in Boone, Raleigh, and Kanawha Counties, West Virginia, approximately 30 miles northeast of the town of Logan. Catenary's operations are in the watersheds of the Big Coal River, the Clear Fork, and Cabin Creek. The Clear Fork flows into the Big Coal River near the town of Whitesville. The Big Coal River meets the Little Coal River near the community of Alum Creek to form the Coal River, which flows into the Kanawha River near St. Albans. Cabin Creek flows into the Kanawha River near the town of Cabin Creek. The Kanawha River flows into the Ohio River near Point Pleasant. Catenary's operations were in the same location in 2004.

6. The operations of Hobet are in Boone and Lincoln Counties, West Virginia, approximately 15 miles north of the town of Logan. Hobet's operations are in the watersheds of the Mud River and the Little Coal River. The Mud River flows into the Guyandotte River near Barboursville, approximately 50 miles downstream of Logan. The Little Coal River meets the Big Coal River near the community of Alum Creek to form the Coal River, which flows into the Kanawha River near St. Albans. Hobet's operations were in the same location in 2004.

7. It would be physically impossible for any water runoff or discharge from the properties or operations of Catenary or Hobet to reach properties located in the Sub-Watershed.

8. Records that I have referred to in connection with the preparation of this Declaration were made at or near the time of the matters set forth in such records, by or from information transmitted by a person with knowledge of those matters, and were made and kept in the course of the regularly conducted business activities of Catenary, Hobet, and their affiliates.

It is the regular practice of those companies to make such records. I am the custodian of such records.
