# THIRD SUPPLEMENTAL DECLARATION OF MATTHEW A. MAZZUCCHI IN SUPPORT OF APPLICATION TO EMPLOY HOULIHAN LOKEY CAPITAL, INC. AS FINANCIAL ADVISOR AND INVESTMENT BANKER FOR THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS

MATTHEW A. MAZZUCCHI, makes this declaration under 28 U.S.C. § 1746, and states the following:

- 1. I am a Managing Director of Houlihan Lokey Capital, Inc. ("Houlihan Lokey") and I am duly authorized to make this third supplemental declaration ("Third Supplemental Declaration") on behalf of Houlihan Lokey.
- 2. I submit this Third Supplemental Declaration in support of Houlihan Lokey's retention application (the "Houlihan Lokey Retention Application")<sup>1</sup> filed in the above-captioned chapter 11 cases (the "Chapter 11 Cases") and in furtherance of Houlihan Lokey's ongoing disclosure obligations under Rule 2014 of the Federal Rules of Bankruptcy Procedure

and pursuant to that certain Order of the Court<sup>2</sup> authorizing the employment of Houlihan Lokey as Financial Advisor and Investment Banker for the Official Committee of Unsecured Creditors (the "Committee") of the above captioned debtors and debtors-in-possession (collectively, the "Debtors").<sup>3</sup> This Third Supplemental Declaration supplements the disclosures provided in the declarations in support of the Houlihan Lokey Retention Application dated September 27, 2012, December 13, 2012 and September 5, 2013 (the "Prior Declarations").

- 3. Unless otherwise stated in this Third Supplemental Declaration, I have personal knowledge of the facts hereinafter set forth.
- 4. Since the filing of the Prior Declarations, Brody Mining, LLC and Patriot

  Ventures LLC (the "New Debtors") commenced Chapter 11 cases on September 23, 2013. On

  September 26, 2013, the Court granted Debtors' Motion for Joint Administration of Brody

  Mining, LLC, Case No. 13-48727 and Patriot Ventures LLC, Case No. 13-48728 with Lead Case

  No. 12-51502.4
- 5. In connection with the filing of the New Debtors' petitions, using the procedures described in the Prior Declarations, Houlihan Lokey conducted a search of its conflicts database using the names listed on a list provided by the Debtors of the principal parties in interest in the New Debtors' Chapter 11 cases which were not already searched for in Houlihan Lokey's most

recent conflicts check, the results of which were included in the Declaration of Matthew A. Mazzucchi dated September 5, 2013 (incremental names are listed on Exhibit A hereto).

- 6. The search described above revealed no connections requiring disclosure.
- 7. As part of its practice, Houlihan Lokey advises in numerous cases and transactions involving many different professionals, including accountants, attorneys, financial consultants and investment bankers, some of whom may represent claimants and parties-in-interest in the Debtors' chapter 11 case. In addition, Houlihan Lokey has in the past, and will likely in the future, work with or against other professionals involved in this case in matters unrelated to this case. Based on our current knowledge of the professionals involved, and to the best of my knowledge, none of these business relations constitute interests materially adverse to the Committee, the Debtors, the New Debtors, or their estates.
- 8. Based on the foregoing, insofar as I have been able to ascertain after diligent inquiry, I continue to believe that Houlihan Lokey does not hold or represent an interest adverse to the Committee, the Debtors, the New Debtors, or their estates in the matters upon which Houlihan Lokey is employed, and Houlihan Lokey remains "disinterested" as such term is defined in section 101(14) of title 11 of the United States Code.
- 9. To the extent that any information disclosed herein requires subsequent amendment or modification upon Houlihan Lokey's completion of further analysis or if any new, material, relevant facts or relationships are discovered, one or more supplemental declarations on behalf of Houlihan Lokey will be submitted to the Court reflecting such amended or modified information.
