If a party wishes to participate in the Hearing remotely, such party must comply with the Order Establishing Certain Notice, Case Management and Administrative Procedures entered on July 16, 2012 [ECF No. 84] and must adhere to the procedures for telephonic participation applicable in the United States Bankruptcy Court for the Southern District of New York, as well as those required by Chambers. The Hearing is scheduled to take place on **September 11, 2012 at 1:30 p.m. (prevailing Eastern Time)**.
