## NOTICE OF WITHDRAWAL OF PROOFS OF CLAIM

U.S. Bank National Association, as trustee (the "Trustee"), is the trustee under that certain Indenture, dated as of May 28, 2008 (the "Indenture"), between Patriot Coal Corporation and the Trustee, under which the 3.25% Convertible Senior Notes due 2013 (the "Convertible Notes") were issued. On December 13, 2013, the Trustee filed Claim No. 2337 against Patriot Coal Corporation in the amount of \$200,169,500, plus other amounts described therein ("Claim No. 2337").
