He had went to the Dr. and a state Trooper found him on the side of the road he didn't know where he was at. I have fibromyalgia and cia out nerve problems now there is days I have to spend in bed. I don't know what I would do without the Medical and medication Ins. I have to have a lot of medication. And what about out pention do they want that back to. I hope God watches over us all. I hope you see what this big rich Company is trying to do to us poor mixing Families.
